The <u>Institute of European Integration and Policy (IEIP)</u> hosts <u>the UNESCO Chair on Climate Diplomacy</u> and the <u>Jean Monnet Module 'European Climate Diplomacy</u>' (a project with the support of the Erasmus+ Programme of the European Union).

The Institute held two international students' simulation in March of 2021. The first concerned the Conference of the Parties of the United Nations Framework Convention on Climate Change, aiming for a better possible agreement for reducing greenhouse gas emissions under the framework of Jean Monnet Module. In cooperation with ELIAMEP, the second simulation concerned the European Commission. The topic was "Climate neutrality and European Climate Law, under the framework of the European Green Agreement". 80 students from 15 countries participated in the simulations.



The annual lecture of the Institute "Discussing about Climate Change", with keynote speaker the Physics Professor Kostas Kartalis, took place on the 5th November of 2020.

The Chair, in collaboration with the Greek National Commission of UNESCO, the Chair on Geoparks and Sustainable Development of coastal and insular areas (Aegean Uni.) and the Chair on Conservation and Ecotourism of Riparian and Deltaic



Ecosystems (International Hellenic Uni.), hosted an international colloquium titled "Preserving the Future: New approaches to Heritage Management and Environmental Protection" on November 16 2020. The colloquium is available <u>here</u>.





The Institute's Director, Professor Emmanuella Doussis, participated in a research project of diaNEOsis on just transition in Greece.
